




8. They shall abide by terms and conditions of the Building and other construction works (Regulations of Employment and conditions of service) Act, 1996.
9. They shall have to produce valid electrical license from the competent authority in the name of contractor at the time of tender. He shall keep valid license throughout the period of enlistment by getting it renewed at suitable intervals and submit an attested copy of the same to the enlistment authority after each renewal. In the event of any discontinuity in validity of electrical license of the contractor its enlistment and authority to work with APWD will also automatically cease to be valid.
10. They shall not modify the existing partnership or enter into fresh partnership without the prior approval of the enlistment authority. Such proposal, if any shall be submitted in advance giving full details of the intended partnership/sole proprietorship along with the draft partnership deed/ affidavit and documents as per Annexure IV of APWD Enlistment Rule-2009 and as amendment made herein after. Any change in status of the contractor as an individual or in constitution of the firm without prior approval of the enlistment authority will render the contractor/firm liable to be removed from the approved list of contractors.
11. They shall not be permitted to tender for works in the APWD circle responsible for award and execution of contract in which their near relatives is posted as Divisional Accountant or as an Officer between the grade of Superintending Engineer and Junior Engineer (both inclusive). they shall also intimate to this office the names of persons who are working with them and who are near relatives of any Gazetted Officer in APWD. For this purpose a near relative shall mean, wife, husband, parents, grandparents, children, grand children, brothers, sisters, uncles, aunts, cousins and their corresponding in law. Any breach of this condition by the contractors shall render them liable to be removed from the approved list of contractors of the department.
12. They shall also intimate change if any of address of their registered office as well as Head office, in advance or maximum within one month of such change. In case of failure to intimate such change to the department, the names would be removed from the approved list of contractors.
13. They shall be bound by the Enlistment Rules 2009 of department as amended from time to time, and liable to be weeded out of non-observance of the same.
14. In case of breach of any of the above-mentioned terms & condition (Sl. No.01 to 13), this order will be deemed to be canceled.


