The above officers shall be on probation for a period of two (02) years in the post of Assistant Engineer (Civil) with effect from the date of reporting duty on regular promotion.

On their regular promotion against the post of Assistant Engineer (Civil), they are entitled to exercise an option to get their pay fixed in the promotional post in accordance with the provisions contained under the Saving Clause of FR22(1)(a)(1). The option shall be exercised within one month from the date of issue of this order and said option once exercised shall be final.

In case their pay has already been fixed under ACP/MACP scheme in the Grade pay of ₹4600/- under the provision of FR-22(1)(a)(1), no further pay fixation benefit shall be accrued to them in terms of condition-09 of Annexure-I of GOI, DOPT's OM No 35034/1/97-Estt(D) dated 09.08.1999 and OM No 35034/3/2008-Estt(D) dated 19.05.2009.

In respect of matters not specified above, they will be governed by the rules and orders issued by the Govt. of India from time to time in respect of official of their category working under the A&N Administration.

On their promotion the above official will continue to perform duty in the same place of posting where they held the post of Assistant Engineer (Civil) on CDC.

Their pay in the post of Assistant Engineer (Civil) will be fixed under the normal rules.
