#### Terms and Conditions:

- They shall be on probation in the post of Junior Engineer (Civil) for a period of 02 (two) years.
- On their regular promotion to the post of Junior Engineer (Civil), they are entitled to
  exercise option to get their pay fixed in the promotional post in accordance with the
  provisions contained under the savings clause of FR 22(1) (a) (1). The option shall be
  exercised within one month from the date of issue of this order and the said option
  once exercised shall be final.
- In case their pay have already been fixed under MACP Scheme in the Pay Level-6 of Rs. 35400-112400 of CCS (Revised) Pay Rules, 2016 under the provisions of FR 22 (1) (a) (1), no further pay fixation benefits shall be accrued to them in terms of condition -09 of Annexures-I of the Government of India, Ministry of Personnel, Public Grievances & Pensions (Department of Personnel & Training), New Delhi OM No. 35034/1/97-Est(D) dated 09.08.1999 and OM No. 35035/3/2008-Estt(D) dated 19.05.2009.

Their seniority shall be determined in the above mentioned order of JE (Civil) of this department in accordance with the instructions guidelines issued by the Government of India on the subject from time to time.

In respect of matter not specified above, they will be governed by the relevant rules and
orders issued by the Govt. of India from time to time in respect of similar category of
official/employees serving/working under APWD, A&N Administration.
