In exercise of the powers vested in him vide Govt. of India, Ministry of Home Affairs Order No. 4/85/68-ANL dated 02/04/1969 and on the recommendation of UPSC vide letter No. 3/12(1)/2025-PD-7 dated 24th October 2025, the Hon'ble Lt. Governor (Administrator), A&N Islands has been pleased to order the appointment of **Shri T.K. Prijith Rekh** to the post of Chief Engineer (Civil) in the pay level -14 (Rs. 144200-218200) (Pre-revised pay scale PB - 4 Rs. 37400-67000 + GP of Rs. 10000) in Andaman Public Works Department, A&N Administration on deputation basis for a period of 03 years in the first instance with effect from the date of his reporting for duty which is extendable in terms of the provisions of Recruitment Rules/guidelines/instructions issued by GoI from time to time on the following terms and conditions.

Terms and Conditions:-

1. Besides Basic Pay, he is entitled to draw Special Compensatory Allowance as admissible at the rate in force and as amended from time to time.
2. Dearness Allowance as admissible under Central Government rate.
3. Rent free unfurnished accommodation, subject to general review/availability.
4. Free sea passage once in year for the Govt. Servant and his family members while proceeding/returning from leave in accordance with orders in force from time to time.
5. TA for journey on duty during the period of deputation will be regulated under the Rules governing the employees of the A&N Administration.
6. He shall also be governed by Rules and Orders in force in respect of the officer of his category serving under the A&N Administration.
7. In respect of the matters not specified above the officer will be governed by the Rules, Regulations and Orders applicable from time to time to the Govt. Servant of his category serving under the A&N Administration.

He shall have the option of draw his pay in the scale of pay attached to the post of Chief Engineer (Civil) in APWD plus usual allowances as admissible at Central Government rate from time to time or the scale of pay applicable to the post held by him in his parent department plus deputation (Duty) allowance at the rate in force and as amended from time to time.
