- 7. In respect of the matters not specified above the officer will be governed by the Rules, Regulations and Orders applicable from time to time to the Govt. Servant of his category serving under the A&N Administration.

He shall have the option of draw his pay in the scale of pay attached to the post of Chief Engineer (Civil) in APWD plus usual allowances as admissible at Central Government rate from time to time or the scale of pay applicable to the post held by him in his parent department plus deputation (Duty) allowance at the rate in force and as amended from time to time.
