On their regular promotion against the post of Assistant Engineer (Civil), they are entitled to exercise an option to get their pay fixed in the promotional post in accordance with the provision contained under the saving clause of FR 22 (I) (a) (1). The option shall be exercised within one month from the date of issue of this order and said option once exercised shall be final. In case their pay has already fixed under ACP/MACP scheme under the provision of FR- 22 (I) (a) (1), no further pay fixation benefit shall be done.

The officers whose case have been kept under sealed cover are completely exonerated, the due date of their promotion will be determined with reference to the position assigned to them in the findings kept in the sealed covers and they will be promoted notionally with reference to date of promotion of their next juniors, if necessary, by reverting the junior most persons officiating on Officiating basis.

In respect of the matters not specified above, they will be governed by the rules and orders issued by the Govt. of India from time to time in respect of officers of their category working under the A&N Administration.
