
In case his pay has been already fixed under ACP/MACP scheme in the Grade Pay of Rs. 4200/- or higher under the provision of FR22(1)(a)(1), no further pay fixation benefit shall be accrued to him in terms & condition 09 of Annexure-I of the Govt. of India, Ministry of Personnel Public Grievance & Pension (Department of Personnel Training), New Delhi OM No. 35034/1/1997-Estt(D) dated 09/08/1999 O.M. No. 35034/3/2008-Estt(D) dated 19/05/2009.

On promotion to the post on their regular basis, they are entitled to exercise an option to get his pay fixed in the promoted post in accordance with provision contained under saving clause of FR22(1)(a)(1). The option shall be exercised within one month from the date of issue of this order. The option once exercised shall be final.

They shall be on probation in the post of Draughtsman Grade-II (Civil) for a period of 2 (two) years.
