TERMS AND CONDITIONS:-

1. That the cases where extension of revalidation has been awarded for a period less than that applied for, the contractor shall apply for further extension of revalidation 03 months prior to the expiry of validity of revalidation awarded. Further extension shall be awarded based on work execution/performance of the contractor.
2. They shall be eligible to tender for APWD works in the appropriate category without prejudice to the rights of the department to prescribe/modify the limits of tendering.
3. They shall be required to deposit Earnest Money with each tender as per terms and conditions of the tender/Agreements.
4. They shall be required to submit performance guarantee before award of the work and security deposit will be recovered from their bills in accordance with rules in force from time to time.
5. They shall be required to continue to have permanent Engineering establishment capable of dealing with works of large magnitude in all stages. They shall be required to intimate changes in their Engineering establishment as and when such changes are made.
6. They shall employ the required technical staff as per terms and conditions of each contract/agreement.
7. They shall have to abide by terms and conditions of the NIT/Contract/Agreement, contract Labour (R&A) Act 1971 and the Child Labour Prohibition and Regular Act, 1986 or as may be altered from time to time.
8. They shall be abide by terms and conditions of the Building and other construction works (Regulations of Employment and conditions of service) Act, 1996.
9. **The electrical contractor (SL. No. 11) shall have to produce valid electrical license from the competent authority in the name of contractor at the time of tender. They shall keep valid license throughout the period of enlistment by getting it renewed at suitable intervals and submit an attested copy of the same to the enlistment authority after each renewal. In the event of any discontinuity in validity of electrical license of the contractor its enlistment and authority to work with APWD will also automatically cease to be valid.**
10. They shall not modify the existing partnership or enter into fresh partnership without the prior approval of the enlistment authority. Such proposal, if any shall be submitted in advance giving full details of the intended partnership/sole proprietorship along with the draft partnership deed/ affidavit and documents as per Annexure VI of APWD Enlistment Rule-2017 and as amendment made herein after. Any change in status of the contractor as an individual or in constitution of the firm without prior approval of the enlistment authority will render the contractor/firm liable to be removed from the approved list of contractors.
11. They shall not be permitted to tender for works in the APWD circle responsible for award and execution of contract in which their near relatives is posted as Divisional Accountant or as an Officer between the grade of Superintending Engineer and Junior Engineer (both inclusive). They shall also intimate to this office the names of persons who are working with them and who are near relatives of any Gazetted Officer in APWD. For this purpose a near relative shall mean, wife, husband, parents, grand-parents, children, grand children, brothers, sisters, uncles, aunts, cousins and their corresponding in law. Any breach of this condition by the contractors shall render them liable to be removed from the approved list of contractors of the department.
12. They shall also intimate change if any of address of their registered office as well as Head office, in advance or maximum within one month of such change. In case of failure to intimate such change to the department, the names would be removed from the approved list of contractors.
13. **In case of breach of any of the above-mentioned terms & condition (Sl. No.01 to 12), this order will be deemed to be cancelled.**
