Governor (Administrator), Andaman & Nicobar Islands is pleased to order the promotion of the following Assistant Engineer (E&M) to the post of Executive Engineer (E&M) [GCS, Group 'A', Gazetted, Non-Ministerial in the Level-11 of the Pay Matrix] in Andaman Public Works Department, A&N Administration on regular basis with effect from the date of their joining to the post.

Subject to condition that:

1. They shall be on probation for the period of 2 years.
2. Their pay shall be fixed under the normal rules as applicable to the Central Govt. Employees.
3. In respect of the matters not specified above, they will be governed by the rules and orders issued by the Govt. of India from time to time in respect of officers of their category working under the A&N Administration.

On their regular promotion against the post of Executive Engineer (E&M), they are entitled to exercise an option to get their pay fixed in the promotional post in accordance with the provisions contained under the saving clause of FR 22(I)(a)(1). The option shall be exercised within one month from the date of issue of this order and said option once exercised shall be final. In case their pay has already been fixed under ACP/MACP scheme under the provision of Fr-22(1)(a)(1), no further pay fixation benefit shall be accrued to them in terms and condition 9 of Annexure - I of GOI, DOPT's OM No. 35034/1/97-Estt(D) dated 09.08.1999 and OM No. 35034/3/2008-Estt(D) dated 19.05.2009.

The recommendation of the DPC shall be subject to further orders may be passed by the Supreme Court of India in Jarnail Singh & Ors batch of cases which is pending in the Supreme Court.


