Pursuant to the order dated 06.11.2024 passed by the Hon'ble High Court, Kolkata, Circuit Bench at Sri Vijaya Puram in the matter of WPA(P)/3/2022 (Court in its own motion -vs- The Lt Governor & Ors) whereby the Hon'ble Court has expanded the scope of the PIL and has included the APWD and PBMC in addition to NHIDCL under purview of the matter, the Chief Engineer, APWD is pleased to designate Shri R S Vanmeeka Nathan, Junior Engineer (Techno Legal) as Nodal Officer to represent the entire APWD in the said matter in coordination with concerned Executive Engineers of APWD.

The Nodal Officer shall directly deal with the concerned Executive Engineers in collecting information of the status of roads and the data regarding steps taken to improve the road under the jurisdiction of APWD with the approval of competent authority and file the compiled report before the Hon'ble High Court, Kolkata, Circuit Bench at Sri Vijaya Puram as per the directions of the Hon'ble Court.
