Whereas, Shri. Pran Gopal Das, contractor, R/o Havelock was enlisted as class-III (Civil) APWD vide O/o No. 367 dt: 04/04/2007, valid for a period of 05 (Five) years from the date of issue of order.


Whereas, CBI had recommended to black list Shri. Pran Gopal Das from approved list of contractor from APWD, which was approved by the Hon'ble Lt. Governor (Enlistment Authority). Accordingly a Show Cause Notice was issued vide letter No. 63(10)/2011-12/CE/APWD/Fin/83/1116 dt: 05/03/2012.

Whereas, being aggrieved Shri. Pran Gopal Das filed W.P. No. 169 of 2012 before Hon'ble High Court at Kolkata, Circuit Bench at Port Blair. The Court disposed off the W.P. with direction to concerned authority to consider and decide the whole objection before entering into merit of reply submitted by petitioner. Accordingly the objection was considered and it was clarified vide order 63(10)/2011-12/CE/APWD/Fin/83/2534 dt:20/06/2012 that Finance Officer to Chief Engineer being Member Secretary of Enlistment Board has the authority to issue a Show Case Notice to contractor.

Whereas, the reply of show case notice submitted by Shri. Pran Gopal Das was considered and it was found that Shri. Pran Gopal Das contractor had involved in complaints of serious nature received from CBI which prima facie appears to be true. Hence, decision was taken by Enlistment Board for Enlistment (Class-I to Class-IV contractor in APWD) for black listing Shri. Pran Gopal Das, which was also approved by Enlistment Authority i.e., Hon'ble Lt. Governor.

Now therefore, as per clause 23.3.(f) of Enlistment Rule, enlistment authority is pleased to black list Shri. Pran Gopal Das contractor Havelock from approved list of contractor.

Further, as per Hon'ble Court direction dt: 30/03/2012 this order will be effective from two week after the date of issue.


