NOTIFICATION

Port Blair, dated the 04th January, 2018.

No. 01/2018/F. No. 33-5/2017-PWD.— In continuation of Administration's Notification dated 19.06.2017 and in accordance with the Memorandum issued by the Superintending Engineer (C&M), CPWD, Nirman Bhavan, New Delhi vide No. DG/SE/CM/ENLIST RULES/28 dt. 17.07.2017, the Lt. Governor (Administrator), Andaman and Nicobar Islands has been pleased to amend in the existing provision of the Enlistment Rules of Contractor in APWD, 2017, namely :-

1	Short title and commencement :
(i)	These Rules may be called the Enlistment (Amendment) Rules of Contractors in APWD, 2017.
(ii)	They shall come into force on the date of their publication in the Official Gazette.

AMENDMENT

2	After Rule 11.3 of the Enlistment Rules of Contractor in APWD, 2017 (hereinafter called Principle Rule), the following shall be added as 11.4. All the enlisted contractors/applicants are required to obtain valid GST registration on the date of application for Enlistment/Revalidation/Up-gradation whichever is earlier.
3	In Rule 23.2 of the Principle Rules, the following shall be substituted :- Suspension of business : Whenever adverse reports related to adverse performance, misbehavior, direct or indirect involvement in threatening, making false complaints, filing legal suites for frivolous reasons, hampering tender process or execution of contractor any act, omission or commission etc., damaging the reputation of department/officer not obtaining GST registration on date of application for tender , or any other type of complaints considered fit by enlistment authority, are received from more than one officer or at more than one occasion from individual officer of APWD/CPWD/ALHW/MES/PBMC/Zilla Parishad etc. (Govt. of Andaman UT) works for the various class/categories of contractor, sale of tender to such APWD contractors shall be suspended immediately by the Enlisting Authority pending full enquiry into the allegations and decision by the empowered committee as indicated below. The committee will decided the case in time bound manner from the date of issuance of letter of suspension of sale of tender to the contractor.

<p>If any of the charges are established then this would result in banning of business with the contractor for the period as decided by Empowered Committee. Business may also be suspended with a contractor upto a period of one year in case he fails to start the work after the award on two occasions.</p> <ul style="list-style-type: none"> Empowered Committee for Civil, Civil Road, Electrical, Horticulture, Furniture & Nursery :

<p>Note : The Chief Engineer, APWD shall appoint the member of the committee as per the table above and it is to be kept in view that complainant officer should not be part of committee.</p> <p>It is also to be ensured that name of the contractor who has been suspended or banned is included immediately in the list of suspended/banned category of contractors on APWD website so that the field offices have an immediate access to the information across the A & N Islands and tenders are not sold to such contractors”.</p>				
4	<p>In annexure-I Appended with the Principle Rule, after clause 20(iv) the following shall be added 20(v) “I/We certify that I/we possess or have obtained registration on GST bearing Number.....”.</p>			
5	<p>In annexure-VIII Appended with the Principle Rule, after clause 16(iv) the following shall be added 16(v) “I/We certify that I/we possess or have obtained registration on GST bearing Number.....”.</p>
