CIRCULAR

Sub: Reimbursement of Medical claim for treatment taken from private hospitals in and around Sri Vilaya Puram (Port Blair).

Reference is made to this Office Circular No. 53(28)/CE/PW/ESIV/PF-III/1652 dated 11/03/2020, regarding the reimbursement of medical claims for treatment taken from private hospitals in and around Sri Vijaya Puram.

Several representations have been received in the Department requesting a review of Circular No. 53(28)/CE/PW/ESIV/PF-III/1652 dated 11/03/2020 and to allow reimbursement of medical claims for treatment taken in and around Sri Vijaya Puram. These requests have been thoroughly examined at all levels, in terms of Central Services (Medical Attendance) Rule, 1944 and directions have now been issued accordingly.

It has now been decided to allow the reimbursement of medical claims for treatment taken by Government Servants and their entitled family members from Authorized Medical Attendants (AMA) in and around Sri Vijaya Puram, strictly in accordance with the provisions under Appendix VIII of the CS (MA) Rules, 1964 on emergency certificate.

All the SEs/EE's/HoO under APWD should strictly follow the procedure of the treatment and comply with the provisions of CS (MA) rules, ibid.
