May I gently remind you of my earlier letter dated 16 April 2026 requesting nomination from your kind good-self for the prestigious Swami Rama Humanitarian Award-2026.

The date for receipt of nomination has since been extended to 15 September, 2026. Your valuable recommendation is of great importance to us. In order to enable you to nominate for the award, a brief as to who can be nominated is submitted here under for your kind reference:

"A person or an institution who worked selflessly towards social, economic and political transformation for the amelioration of human suffering particularly of the less-privileged sections of society contributing to social justice and harmony irrespective of whether the person holds a high public office or not will be considered for the award by the jury. The award is open to all persons regardless of nationality, race, creed or sex. Recent achievements within 10 years of the nomination shall be considered. Older work may be considered if its significance has become apparent only recently. A written work, in order to be eligible for consideration, should have been published."

The award carries a Citation, a Plaque and an amount of Rs.10,00,000/- (Rupees ten lakh only). The awardee is chosen by a Jury headed by Hon'ble Justice Sudhanshu Dhulia, Former Judge Supreme Court of India.
