Sub: - Issue of Online Admit Card to the eligible candidate for appearing in the Recruitment Examination of JE (C) and JE (E&M) of APWD- reg.

It is to inform to all the eligible candidates who have applied for the post of Junior Engineer (Civil) and Junior Engineer (E&M) are hereby informed that the written examination for the post of Junior Engineer (Civil) and Junior Engineer (E&M) of APWD is schedule to conduct on **21st July, 2019 from 10:00 A.M. to 12:00 Noon and from 03:00 P.M. to 05:00 P.M.** respectively.

The Admit Card for the written examination to the eligible candidate for appearing in the Recruitment Examination for the post of Junior Engineer (Civil) and Junior Engineer (Electrical & Mechanical) of APWD will be issued online from **05th July, 2019 onwards and will be available up to 21st July 2019 only**. INSTRUCTIONS TO THE CANDIDATES (To be published in the website)

1. The written examination for the post of **Junior Engineer [Civil]** will be held on **(Sunday) 21.07.2019 in the forenoon session** from **10:00 A.M. to 12:00 Noon** and written examination for the post of **Junior Engineer [Electrical & Mechanical]** will be held on **(Sunday) 21.07.2019 in the afternoon session** from **03:00 P.M. to 05:00 P.M.** The candidates are advised to reach/report Examination Hall at least one Hour before the commencement of the Examination. Questions shall be answered by the candidate in the computerized OMR Answer Sheet with Black Ball Point Pen only by darkening the circles.
 2. No Candidate will be allowed to enter the Examination Hall after **10:15 A.M.** for the post of **Junior Engineer [Civil]** and after **03:15 P.M.** for the post of **Junior Engineer [Electrical & Mechanical]** respectively.
 3. The candidate must bring the original Admit Card at the Examination Centre. No candidates will be allowed entry without the admit card. The candidate is also required to bring one ID Card issued by Government (viz. Voter ID, Driving License, PAN Card, Aadhaar Card, Islander Card, Passport) along with the Admit card. The identity of the candidates shall be matched with the identity proof. The candidates are advised to bring two recent passport size photographs for examination.
 4. Possession and use of electronic devise such as Mobile Phone, Micro phone or any other Associated Accessories Calculator, Log Tables, Pager, Digital Diary, Electronic Watch, Book/ Note etc. are strictly prohibited in the Examination Hall. If any candidate is found in possession or any of these in the Hall, his/her candidature will be cancelled. Andaman Public Works Department will not be responsible for safe custody of any of the personal belonging of the candidate in the Exam Center.
 5. Please retain this Admit Card for future record and to be produced at any stage of recruitment processes even after qualifying the written examination.
 6. The written examination shall consist of 100 multiple choice objective types Question. There shall be one correct answer for each Question and it has to be marked in the OMR sheet. The paper will be of 02 hours duration. Each correct answer will be awarded two marks. There is negative marking, i.e. 0.50 Marks shall be deducted for each wrong answer or multiple answers for same question.
 7. The candidates appearing in the written exam shall, on their own interest, check their eligibility in all respect, so as to avoid disappointment at later stage. The candidature for the written test is "Purely PROVISIONAL" subject to fulfilling the eligibility conditions mentioned in the Advertisement for the post. If any information provided by the candidate is found false or not in conformity with the eligibility criteria mentioned in the advertisement, candidature of such candidate will be liable to be rejected at any stage of recruitment process or even after joining the post.

 10. No TA/ DA will be admissible for the candidates appearing in the written examination.
