The option shall be exercised within one month from the date of issue of this order and said option once exercised shall be final.

In case their pay has already been fixed under ACP/ MACP Scheme in the Grade Pay of Rs.4600/- under the provisions of FR 22(1)a(1), no further pay fixation benefit shall be accrued to them in terms of condition-09 of Annexure-I of the Govt. of India, Ministry of Personnel, Public Grievances & Pension (Department of Personnel & Training), New Delhi O.M No.35034/97-Estt.(D) dated 09.08.1999 and O.M No.35034/3/2008-Estt.(D) dated 19.05.2009.

In respect of matters not specified above, they will be governed by the rules and orders issued by the Govt. of India from time to time in respect of official of their category working under the A&N Administration.

On their promotion the above officials will continue to perform duty in the same place of posting where they held the post of Assistant Engineer (Civil) on CDC.
