ORDER NO. 502

Sub: Supply, installation, testing and commissioning of 01 Nos. Passengers lift at Indira Bhawan.

PBMC has entered into an agreement with Shri. Vinit Naidu, Govt. Contractor to execute the work "Supply, installation, testing and commissioning of 01 Nos. Passengers lift at Indira Bhawan" vide Agreement No. 06 (Wks-I) of 2018-19. The lift was commissioned in December 2019 and hardly remained operational for a month. The non-functioning of the lift is causing serious inconvenience to the physically disabled persons and senior citizens visiting the office for various services.

Taking a serious view a show cause notice was also issued to the contractor in May 2022, but the elevator has not been made functional till date

The matter has been viewed seriously and accordingly it has been decided to take stern action against the contractor for supplying sub-standard equipment which remained non-operational after commissioning and resulted not only loss of money to the PBMC ex chequer but also caused serious inconvenience to the public.

Whereas it has been decided to debar Shri. Vinit Naidu, Contractor for any further contracts in PBMC. An action and inquiry also initiated against the work executed by the contractor for the non function of the elevator.

It is therefore decided to debar the said contractor Shri Vinit Naidu to participate in any form of tendering process for such contracts for a period of two years. The period of debarment shall start from the date of issue of this order.
