**Terms and Conditions:**

- On their regular promotion to the post of Draughtsman Grade-I (Civil) they are entitled to exercise option to get their pay fixed in the promotional post in accordance with the provisions contained under the saving clause of FR 22(1) (a) (1). The option shall be exercised within one month from the date of issue of this order and the said option once exercised shall be final.
- In case their pay have already been fixed under ACP/MACP Scheme in the Pay Matrix Level-6 of Rs. 35400-112400 of CCS (Revised Pay) Rules, 2016 (Pre-revised scale of Pay of Rs.9300-34800 + GP-4200/- in PB-2) under the provisions of FR 22 (1) (a) (1), no further pay fixation benefits shall be accrued to them in terms of condition-09 of Annexures-I of the Government of India, Ministry of Personnel, Public Grievances & Pensions (Department of Personnel & Training), New Delhi OM No. 35034/1/97-Est(D) dated 09.08.1999 and OM No. 35035/3/2008-Estt(D) dated 19.05.2009.
