claim, duly forwarded by concerned HOO so as to reach this office in the stipulated time. Claim to retain on other grounds i.e. medical, spouse posting etc should also be supported by valid documentary evidence.

On receipt of the responses (If any) the matter shall be placed before the Establishment board. It may be noted that no claims will be entertained after issue of Final transfer order. It may also be noted that the names of the official considered by the board for retention may not form part of final order and the place of posting may be changed on the recommendation of the board, which will be final. Names of few officials will be placed as substitutes. In addition to above the establishment board may also order transfer of officials within Zone -I on public interest.
