Terms and Conditions:

The option shall be exercised within one month from the date of issue of this order and the said option once exercised shall be final.
- In case their pay have already been fixed under ACP/MACP Scheme in the Pay Matrix Level-7 of Rs. 44900-142400 of CCS (Revised Pay) Rules, 2016 (Pre-revised scale of Pay of Rs.9300-34800 + GP-4600/- in PB-2) under the provisions of FR 22 (1) (a) (1), no further pay fixation benefits shall be accrued to them in terms of condition-09 of Annexures-I of the Government of India, Ministry of Personnel, Public Grievances & Pensions (Department of Personnel & Training), New Delhi OM No. 35034/1/97-Est(D) dated 09.08.1999 and OM No. 35035/3/2008-Estt(D) dated 19.05.2009.
