Whereas, the firm M/s: Sai Construction Company, (Prop. Shri.Jaisj Kumar, authorised representative Shri. Neeraj Kumar), Phoniex Bay, Port Blair was enlisted in Class - IV (Civil) in APWD vide order No.1167, dated 17/08/2011 based on the technical qualification of the proprietor i.e. Shri. Jalaj Kumar, being an unemployed Graduate Engineering in Civil from the University of Roorkee in the year 1996. On verification of the Engineering Degree Certificate from the Registrar IIT, Roorkee, it was come to light that no such Degree Certificate was issued by the University.

Whereas, in accordance to Rule -23 of APWD Enlistment Rule - 2009 a Show Cause Notice was issued vide letter No. 63(10)/2010-11/CE/APWD/Fin/PF/4433 dt: 12/12/2013 to explain why action should not be taken to remove the firm, from the approved list of contractor in APWD, in accordance to Rule 23.3 (e) & (f) of APWD Enlistment Rule - 2009 i.e "Is found to have given false particulars at the time of enlistment" & "has indulged in any type of forgery or falsification of records", but the firm had falled to reply to the Show Cause Notice. Accordingly the matter was placed before the Enlistment Board who recommend to remove the firm from the approved list of the contractor in APWD which was approved by the Hon'ble Lt. Governor (Enlistment Authority).

Now therefore, the Enlistment Authority is pleased to remove the firm M/s Sai Construction Company, Port Blair from approved list of contractor in APWD with Immediate effect.
