1. संक्षिप्त नाम और प्रारंभ :-

- (i) इन नियमों को अण्डमान तथा निकोबार प्रशासन (अण्डमान लोक निर्माण विभाग) (संशोधन) भर्ती नियम, 2014 कहा जा सकेगा ।
- (ii) ये नियम इनके सरकारी राजपत्र में प्रकाशित होने की तिथि से प्रवृत्त होंगे ।

2 (क) दिनांक 03.02.2014 के अधिसूचना सं.14/2014/फा.सं. 4-22/2012-लो.नि.वि. के अनुसूची के क्र.सं. 10 के सामने उल्लिखित वर्तमान प्रविष्टियाँ इस प्रकार प्रतिस्थापित होगी :

"पदोन्नति द्वारा, ऐसा न होने पर अल्पावधि अनुबन्ध सहित प्रतिनियुक्ति द्वारा ।"

2 (ख) दिनाँक 03.02.2014 के अधिसूचना सं.14/2014/फा.सं. 4-22/2012-लो.नि.वि. के अनुसूची के क्र.सं. 11 के सामने उल्लिखित वर्तमान प्रविष्टियाँ इस प्रकार प्रतिस्थापित होगी :

पदोन्नति :

अधीक्षण अभियंता (सिविल) जिन्होंने ₹ 37,400-67,000 + ग्रे.वे. ₹ 8700 वेतनमान पर तीन वर्षों की नियमित सेवा की हो तथा किसीं मान्यताप्राप्त विश्वविद्यालय/संस्थान से सिविल अभियांत्रिकी में स्नातक उपाधि प्राप्त की हो ।

- (क) (i) जो मूल संवर्ग/विभाग में नियमित आधार पर समकक्ष पदधारी है। या

No. 55/2014/ F.No 4-22/2012-PWD.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, read with the Government of India, Ministry of Home Affairs, New Delhi, Notification No U-14039/2/83-ANL dated 21st February, 1985 and the UPSC's Letter No. F.3/30(50)/2013-RR dated 7th January, 2014 and dated 13.03.2014, the Lieutenant Governor (Administrator), Andaman and Nicobar Islands hereby makes the following Amendments to the Andaman and Nicobar Administration (Public Works Department) Recruitment Rules, 2014 published in Andaman and Nicobar Gazette Notification No. 14/2014/F.No. 4-22/2012-PWD dated 03.02.2014, namely:-

1. Short Title and Commencement :-

- i. These rules may be called the Andaman and Nicobar Administration (Public Works Department) (Amendment) Recruitment Rules, 2014.
- ii. They shall come into force on the date of their publication in the Official Gazette.

AMENDMENT

2 (A) The existing entries mentioned against Col. 10 of Schedule of the Notification No.14 /2014/F.No 4-22/2012-PWD dated 03.02.2014 shall be substituted as under :-

"By promotion failing which by deputation including short-term contract"

2 (B) The existing entries mentioned against Col. 11 of Schedule of the Notification No. 14/2014/F.No 4-22/2012-PWD dated 03.02.2014 shall be substituted as under :-

Promotion:

The Superintending Engineer (Civil) in Pay Band-4 ₹ 37400-67000 + Grade Pay of ₹ 8700 with three years regular service in the grade and possessing a Degree in Civil Engineering of a recognized University or Institute.

Note:

The officer promoted to the grade of Chief Engineer (Civil) shall undergo two weeks training course on Higher Management in a recognized Institute.

Note:1

Where juniors who have completed their qualifying /eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying/eligibility service by more than half of such qualifying/eligibility service or two years, whichever is less, and successfully completed their probation period for promotion to the next higher grade alongwith their juniors who have already completed such qualifying/eligibility service.

Note: 2

For the purpose of computing minimum qualifying service for promotion, the service rendered on a regular basis by an officer prior to 01.01.2006/the date from which the revised pay structure based on the 6th CPC recommendation has been extended shall be deemed to be service rendered in the corresponding Grade Pay / Pay Scale extended based on the **recommendation of the Pay Commission**.

Deputation (ISTC):

Officers under the Central Government/State Govt. or Semi-Government / Autonomous/ Statutory Organization/ PSUs or Faculty of Universities/Recognized Research Institutions:-

(a) (i) Holding analogous post on regular basis in the parent cadre/department;

OR

(ii) With 3 years service in the grade rendered after appointment thereto on a regular basis in the Scale of Pay in PB-4 of ₹ 37400-67000 with Grade Pay of ₹ 8700 or equivalent in the parent cadre/department;

OR

iii) With 8 (eight) years service in the grade rendered after appointment thereto on a regular basis in the Scale of Pay in PB-3 ₹ 15600-39100 with Grade Pay of ₹. 7600 or equivalent in the parent cadre/department;

and

- (b) Possessing the following educational qualification and experience:-
 - (i) Degree in Civil Engineering of a recognized University/Institute.
 - (ii) 15 years of experience in Planning, Designing, Construction and Execution of Civil Engineering Projects including atleast 2 years of Administrative Experience. The Departmental Officer in the feeder category who is in the direct of promotion will not be eligible for consideration for appointment on deputation. Similarly, the deputationist shall not be eligible for consideration for appointment by promotion

Note 3:

(Period of deputation (ISTC) including the period of deputation (ISTC) in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Govt. shall ordinarily not to exceed 5 (five) years).

The maximum age limit for appointment by deputation (ISTC) shall not be exceeding 56 years as on the closing date of receipt of applications.

Note: For the purpose of appointment on deputation basis, the service rendered on regular basis by an officer prior to 01-01-2006/ the date from which the revised pay structures based on the VIth CPC recommendation has been extended shall be deemed to be the service rendered in the corresponding Grade Pay/ Pay Scale extended based on the **recommendation of the Pay Commission** except where there has been merger of more than one pre-revised Pay Scale in to one Grade with a common Grade Pay/ Pay Scale, and where this benefit will extend only for the post(s) for which the Grade Pay/ Pay Scale is the normal replacement grade without any up-gradation.

2 (C) The existing entries mentioned against Col. 13 of Schedule of the Notification No .14/2014/ F.No. 4-22/2012-PWD dated 03.02.2014 shall be substituted as under :-

"Consultation with the Union Public Service Commission necessary while appointing an officer on deputation (ISTC)"

No. 14/2014/F.No. 4-22/2012-PWD.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with the Government of India, Ministry of Home Affairs, New Delhi, Notification No. U-14039/2/83-ANL dated 21st February, 1985 and the UPSC's letter No. F.3/30(50 /2013-RR) dated 7th January, 2014 and also, in supersession of earlier Notification No. 290, dated 11th April, 1991, the Lieutenant Governor (Administrator), Andaman and Nicobar Islands, hereby makes the following rules regulating the method of recruitment to the post of **Chief Engineer** (Civil) in the Public Works Department, Andaman and Nicobar Administration, namely:—

1. Short title and commencement :-

- i. These rules may be called the Andaman and Nicobar Administration (Public Works Department) Recruitment Rules, 2014.
- ii. They shall come into force on the date of their publication in the Official Gazette.

2. No. of posts, its classification and the scale of pay :-

The number of the said posts, their classification and the scale of pay attached thereto, shall be as specified in paras 2, 3 & 4 of the Schedule annexed to these rules.

3. Method of recruitment, age limit, qualifications :-

The method of recruitment, age limit, qualifications and other matters connected therewith shall be as specified in paras 5 to 13 of the said Schedule.

4. Disqualification :-

No person —

a. Who has entered into or contracted a marriage with any person having a spouse living;

Or

b. Who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such persons and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of these rules.

5. Power to relax :-

Where the Administrator, Andaman and Nicobar Islands, is of the opinion that it is necessary or expedient to do so, it may, by order and for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving :-

Nothing in these rules shall affect the reservations, relaxation of age limit and other concessions required to be provided for the candidates belonging to Scheduled Castes, Scheduled Tribes, Ex-Serviceman and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
